Review of CEP Goals

- Goal 1: Rigorous course work
 - Mr. Cromer: Goals were not rigorous and reviews changes made to the goals
 - Markinson: Language revision for Integrated Algebra to Common Core Algebra
 - College Now at Queens College expansion
- Goal 2: School-wide writing

- Mr. Cromer outlines the various programs and prep that are available to students
 - A+, SAT prep
 - 25-30 students
 - Mr. Cromer: Expensive program to run but will look into expansion to more students
- SAT 2 prep: If there is a need in the school
- Goal 3: College Readiness Plan
 - Performance data for all students shared to teachers
- Goal 4: Increase Parental Involvement
 - Tillett: Parents must be involved in PTA for scholarships that come from the PTA
 - Judy Luong: Students should not be penalized if parents are not involved
 - Tillett: If parents want to be involved, they will be.

School Budget:

- Mr. Cromer: Qualified Title I funding for the following year

Uniform:

- Mr. Cromer: Parent wrote letter identifying several issues
- Mrs. Cordero:
 - The cost of the gym uniform is the same and the quality of the material is better
- Need to have clear uniform policy
 - Can students use old uniform?
 - Is there a deadline?
 - Mr. Cromer: No one is penalizing students for uniform on October 1st.
 - Mrs. Mandel: Ask students if their uniforms were order. If they were, students were given a card and list will be provided to teachers
 - Judy Luong: Title I school, cost. School should provide the cost
 - Schnall: prices for new uniforms are cheaper
 - Mr. Cromer: Uniforms are part of the school culture
 - Markinson: 80% of staff voted for the uniform
 - Keep community, school safety
 - Luong: parents still do not have a voice
- Mr. Cromer: This is not final version, this is a uniform school, no one is going to be penalized
- Ms. Cruz: students were asked for input into uniform
- Mr. Mandel: Please, if you have any concerns, write down and email it to me and we will address.
- Mrs. Luong: We need transparency
- Mrs. Cordero: Fire drill last week, our students is quickly identified.
